TERMS & CONDITIONS

<u>1. Eligibility:</u> 1.1 In case of Super Stockist, He must have his own network of Distribution with at-least 7 Distributors in the network. All activities pertaining to his network are under the purview of Super Stockist only. If he employs any additional member/channel in his district, it should be his sole responsibility to cater to its remuneration and compensation needs. The Firm will directly be dealing with Super Stockist on a Principal to Principal basis in a Buy-Seller Relationship.

1.2 In case of Distributor, he must make a monthly order of at-least Rs. 50,000 and should have optimum number of retailers in his network to drive the growth for the firm.

2. Security: 2.1 Redistribution Stockist (R.S.) to deposit Interest Free Security by Cheque for due performance. Amount of security shall be as per the Firm's Security Policy in force from time to time. The Firm will have the right to deduct all expenses incurred in case of dishonour of Redistribution Stockist Cheques / Documents and any other amounts due to the Firm or its associates/Branches. Security will be refunded to the Redistribution Stockist on termination of Redistribution Stockistship, after settlement of Accounts and adjustment of any amounts due to the Firm. Additionally, the applicant has to submit 2 Blank cheques for security purposes.

<u>3. Payment:</u> 3.1 Full advance by RTGS as per The Firm's Policy in force from time to time. Firm shall not be responsible for any cash payments made to field staff as the same is not permitted.

3.2 Interest @ 15% P.A. is payable on delayed payments.

<u>4. Mode of Dispatch:</u> 4.1 Goods will be sent at buyer's risk through reputed transporters approved by the Firm. Freight payment as per Firm's freight policy in force from time to time.

5. Prices: 5.1 As per The Firm's Price Structure subject to change from time to time. Prices applicable on date of despatch to be charged.

<u>6. Redistribution</u>: 6.1 Redistribution Stockist must visit all Retailers in the Area regularly & ensure proper distribution and placement of The Firm products.

6.2 Redistribution Stockist to extend credit at his own cost & risk.

6.3 Redistribution Stockist must make best efforts to maximise sales and give full co-operation to the Firm and its representatives in every respect.

6.4 The Firm reserves the right to appoint any number of Redistribution Stockists for a particular Town/Area.

7. Redistribution Stockist Margin: 7.1 As per Firm's Price Structure from time to time.

7.2 The Firm will not be responsible for cost/expenses incurred or commitments made in respect of discounts/costs/expenses for which there is no prior written sanction from the Management of the Firm.

<u>8. Termination</u>: 8.1 This arrangement is on Principal to Principal basis. The Termination clauses applicable on this relationship are clearly stated in The **Distributor Agreement** issued by the Firm.

9. Jurisdiction: 9.1 All disputes will be subject to the Exclusive Jurisdiction of Kanpur Courts only.

10. Severability: 10.1 In addition to the provisions abovementioned , together with the **GD Industries Distributor Agreement** shall constitute the entire agreement between GD Industries and the Distributor/Redistribution Stockist with respect to the subject matter hereof.

10.2 In addition to the provisions abovementioned, the Contract and the terms contained therein shall remain effective and shall be binding upon the parties to the contract. However, in case if any provision is determined to be void and unenforceable under laws, then in that case, such provisions of this contract shall be deemed amended or deleted to the extent necessary to conform the laws and the remaining provisions of the Contract shall remain valid and enforceable.

NOTE: The word Firm, wherever it appears, refers to GD Industries.
